ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The final Offer Price has been determined at HK\$0.65 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$0.65 per Offer Share, the net proceeds from the Share Offer, before exercise of the Over-allotment Option, and after deducting the underwriting commission and fees and other estimated expenses payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$78.8 million. The Company intends to apply such net proceeds in accordance with the purposes set out in “Future plans and use of proceeds” in the Prospectus.

Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 16,182 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service for a total of 798,110,000 Public Offer Shares, representing approximately 39.9 times of the total number of 20,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the clawback mechanism as described in “Structure of the Share Offer – Public Offer – Reallocation and clawback” in the Prospectus has been applied. As the number of the Public Offer Shares validly applied for in the Public Offer represents more than 15 times but less than 50 times of the total number of the Offer Shares initially available under the Public Offer, 40,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of Offer Shares allocated to the Public Offer has been increased to 60,000,000 Offer Shares, representing 30% of the total number of Offer Shares available under the Share Offer, and being allocated to successful applicants under the Public Offer.
- The final number of Offer Shares allocated to the Public Offer is 60,000,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Share Offer (before any exercise of the Over-allotment Option).

Placing and Over-allotment Option

- The Offer Shares initially offered under the Placing have been slightly over-subscribed. The final number of Offer Shares under the Placing is 140,000,000 Shares, representing 70% of the total number of the Offer Shares under the Share Offer (before any exercise of the Over-allotment Option). A total number of 79 places have been allotted one board lot of Shares, representing 44.4% of the total number of places under the Placing. These places have been allotted a total of 395,000 Offer Shares, representing approximately 0.3% of the Offer Shares under the Placing assuming the Over-allotment Option is not exercised. A total number of 110 places have been allotted five board lots of Shares or less, representing 61.8% of the total number of places under the Placing. These places have been allotted a total of 735,000 Offer Shares, representing approximately 0.5% of the Offer Shares under the Placing assuming the Over-allotment Option is not exercised.

- None of the Sole Sponsor, the Joint Bookrunners, the Joint Lead Managers, the Underwriters and their respective affiliates, companies and connected clients of the lead broker or of any distributors (as defined in Appendix 6 to the Listing Rules) has taken up any Offer Shares for its own benefit under the Share Offer. The Directors confirm that no Offer Shares have been allocated to applicants who are core connected persons, directors or existing shareholders of the Company or their respective close associates within the meaning of the Listing Rules. The Placing is in compliance with the Placing Guidelines for Equity Securities as set out in Appendix 6 to the Listing Rules (the “**Placing Guidelines**”) and no Offer Shares placed by or through the Joint Bookrunners and the Underwriters under the Share Offer have been placed with any core connected person (as such term is defined in the Listing Rules) of the Company or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. No placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately after the Share Offer (before any exercise of the Over-allotment Option). None of the placees under the Placing will become a substantial shareholder (as defined in the Listing Rules) of the Company after the Placing and the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules. The Directors confirm that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.
- In connection with the Placing, the Company has granted the Over-allotment Option to the Placing Underwriters, exercisable by the Stabilising Manager (for itself and on behalf of the Placing Underwriters), at any time from the date of the Placing Underwriting Agreement to the date which is 30 days after the last day for the lodging of applications under the Public Offer, at its sole and absolute discretion, to require us to allot and issue up to an aggregate of 30,000,000 additional Shares, representing 15% of the initial Offer Shares, at the same price per Offer Share under the Placing to solely meet excess demand, if any, in the Placing. No over-allocation of the Shares was made in the Placing. Therefore, the Over-allotment Option will not be exercised.
